

## INTERVIEW OF WITNESS

LARRY LEON MITCHELL Rt. 1, Box 1666 Benton, Arkansas 847-2981

At approximately 9:35 a.m. on July 13, 1988, Investigator CHUCK TALLENT of the Saline County Sheriff's Office and this investigator interviewed LARRY MITCHELL in reference to information concerning this case. The following will be the information related to this investigator by Mr. MITCHELL.

Mr. MITCHELL stated that on the night KEVIN IVES and DON HENRY were killed that he had just come back from Georgia and had walked from the Super Shell Service Station at the Saline/Putaski County line to GARY PETERS' house in Alexander. MITCHELL stated he arrived at GARY PETERS' house at approximately 2:00 to 2:30 .m. that morning. MITCHELL stated that he didn't knock on the door to wake anyone up but he just went over and got in the swing outside the house and went to sleep. Mr. MITCHELL stated that he did not see anyone while he was walking to the house.

According to Mr. MITCHELL he had been asleep for an hour or so when he heard three rifle or pistol shots and then a large boom that sounded like a shotgun. MITCHELL stated that approximately fifteen (15) to twenty (20) minutes after he had heard the shots that RONNIE GIVENS who is the brother to GARY PETERS came up to the swing. MITCHELL stated that RONNIE GIVENS lives in a house within fifty (50) feet of GARY PETERS' house. MITCHELL stated that RONNIE asked him if he was awake and then asked, "Did I hear that?" Mr. MITCHELL stated that GIVENS then asked, "What's going on down there?" Mr. MITCHELL stated at this time all the cars with the blue lights were there. MITCHELL stated they were not there when he heard the gunshots. MITCHELL stated he did not go down to the scene.

According to MITCHELL he left about three (3) days after the incident to go to work for Georgia Pacific driving a truck. Mr. MITCHELL stated that this is usually who he drives trucks for. According to MITCHELL the Sunday morning of the incident after it was light that GARY PETERS, SKEETER JORDAN, and himself walked down the tracks to where the incident occurred. MITCHELL stated that everyone was wanting to know what had happened.

According to MITCHELL it was not long after the incident that RONNIE GIVENS and his wife left and went to an area outside Chicago. MITCHELL stated that he has talked to GARY PETERS and PETERS stated that he hasn't heard from RONNIE GIVENS since he moved to the Chicago area.

Mr. MITCHELL stated that he drove a car for J. D. MURRAY to Chicago and while they were going to Chicago they were supposed to stop by and see RONNIE GIVENS but they never did. MITCHELL stated that the way he understood it was that J. D. owned the place where RONNIE was staying. MITCHELL stated that he understood that RONNIE left because he was so heavy into cocaine and he had lost his job with Channel 4 in Little Rock and also had lost his house.

MITCHELL stated that he had heard that the boys got into a fight at a party on Alexander Mountain the night they were killed but he didn't know because he was not there. MITCHELL stated that he did not know either one of the boys that had died.



GAYLA HENRY No address information was given by the witness.

This was a phone interview with Ms. GAYLA HENRY who is the sister to DON HENRY. Ms. HENRY did not give her location or her phone number and her father Mr. CURTIS HENRY called this investigator at my office in Hot Springs before the interview and set up the interview for this investigator.

Ms. HENRY stated that it has been along time since the incident and she is trying to block everything out of her memory. Ms. HENRY stated that on the Friday night before the incident around 9:00 p.m., DON came by FREDDY POE's cousin's house where she was at. According to Ms. HENRY, DON just wanted to talk and she doesn't really remember the conversation but she stated that it was nothing out of the ordinary. Ms. HENRY stated that DON stayed about thirty (30) to fourty-five (45) minutes and she's not sure but she thinks that KEVIN IVES was with him at that time.

Ms. HENRY stated that the next day, which was Saturday, DON came over to her house before he went to pick up KEVIN. Ms. HENRY stated the conversation was ordinary and during the conversation DON stated that he was going to go pick up KEVIN IVES. GAYLA stated that DON stated that they were going to cruise Geyer Springs but they would be coming back by her house later. Ms. HENRY stated she had asked DON where his girlfriend LAURA LARUE was and DON told her she was out of town and she seems to think it was somewhere in Oklahoma. According to Ms. HENRY, DON didn't say anything about going hunting that night.

Ms. HENRY stated that she did not see DON again because that night she took FREDDY POE's child to the Benton Speed Boat and was not home if DON and KEVIN had come by. Ms. HENRY stated that FREDDY POE was suppose to be at a guy's house in Benton. Ms. HENRY stated she could not remember the guy's name but she was sure he was with KEITH who drives a white four-wheel drive truck and lives in a trailer behind the car wash in Bauxite.

Ms. HENRY stated that DON did not seem to be troubled or upset and there didn't appear to be anything wrong. Ms. HENRY stated she does not remember but thinks that DON said that he and KEVIN were both looking for a quarter ounce of

marijuana to buy. Ms. HENRY stated she thought that DON said something about going to a guy's house near where KEVIN lived to get the marijuana. Ms. HENRY stated she did not know where the marijuana that the boys bought came from for sure.

Ms. HENRY stated that DON called her one day from CLOUD GRIFFITHS' house and she believes it was the Thursday or Friday before the incident. Ms. HENRY stated that DON advised her that he had went to CLOUD GRIFFITHS' house looking for her and while he was there he tried to buy a quarter ounce of marijuana from CLOUD but CLOUD did not have any marijuana. Ms. HENRY stated that usually if DON was going to buy marijuana he would buy it from her or CLOUD GRIFFITHS.

Ms. HENRY stated that DON never said anything about owing anyone money for drugs and he had a job and he usually had money. Ms. HENRY stated she never heard him say anything about ripping anyone off for drugs. According to Ms. HENRY she didn't hear him say anything about a drug drop in Alexander, but she does remember him saying something about the ultimate dealer who is supposed to be a subject out of Little Rock and this was approximately three (3) weeks before the boys were killes

Ms. HENRY stated that DON never said mything about being in any kind of trouble and they were close enough that if DON was in some kind of trouble he would have told her. Ms. HENRY stated that so the best of her knowledge DON HENRY never dealt with any blacks concerning drugs.

Detective Sergeant GEORGIANNI stated that the victim was walking on the tracks when the in-track train approached him from the rear.

The train crew sounded the hern on the train once and the victim did not respond. The victim continued to walk intil the horn was sounded a second time. After the second sounding the victim turned around, however, the train was too close for him to react and he was struck by the train and was killed instantly.



At approximately 3:10 p.m. on July 15, 1988, this investigator interviewed LAURIE O'NEAL in reference to information concerning this investigation. The following will be the information related to this investigator by Ms. O'NEAL.

Ms. O'NEAL stated that she knew KEVIN IVES because ALICIA IVES was her best friend. Ms. O'NEAL stated that KEVIN ran around with them a lot before they graduated. O'NAL stated that after they graduated she did not see KEVIN that much.

O'NEAL stated that she thought KEVIN may have been arrested for Possession of Marijuana some place out of town. O'NEAL stated that KEVIN was supposed to have been with a friend whose parents were divorced and thought they had gone to visit one of the parents when they were arrested for the marijuana. O'NEAL stated this was the Spring of her senior year in 1986. According to O'NEAL the IVES' family were supposed to have made KEVIN take drug tests at the end of the month to see if he was on drugs.

Ms. O'NEAL stated that ALICIA IVES has never said anything about KEVIN having any problems with drugs or having any problems with anyone. According to Ms. O'NEAL she knew who DON HENRY was but she never talked to him.

At approximately 2:43 p.m. on July 15, 1988, this investigator interviewed DARREN WAYNE O'NEAL in reference to information he might have concerning this investigation. The following will be the information related to this investigator by Mr. O'NEAL.

Mr. O'NEAL stated that his stster AURIE O'NEAL knew KEVIN IVES' sister ALICIA IVES and this is how be got to know KEVIN IVES. O'NEAL stated he also knew KEVIN from school.

According to O'NEAL his relationship with KEVIN IVES at first was not that good but later developed into a good friendship. O'NEAL stated that first he just didn't have time for another friend. According to O'NEAL, DON HENRY came over to his trailer on a couple of occasions and on at least one occasion that he was sure of he sold cocaine. O'NEAL stated that he was on drugs real bad and that he does not remember who DON sold the drugs to. O'NEAL stated that JEFF MADDEN and EDDIE GRIEBEL were at the trailer and it could have been one of them or several others that DON HENRY sold the cocaine to. O'NEAL stated that he took LSD and used marijuana during this time and he was in real bad shape from these drugs. O'NEAL stated that later he had to go to the Baptist Care Unit for help concerning his drug problem. O'NEAL stated that he knew DON sold and it was a common fact but he never saw him with any cocaine. O'NEAL stated that DON supposedly had a large connection for cocaine. O'NEAL stated that he thought that KEVIN may have dealt some marijuana but not cocaine. According to O'NEAL he has known KEVIN for about three to four years and DON for about a year. O'NEAL stated that he had heard a lot of speculation , rumors and myths but that the main one was about a marijuana patch. O'NEAL stated that supposedly the boys had been to a marijuana patch and some blacks had thrown them out and threatened to kill them if they ever came back. O'NEAL stated that there was a Bryant Police Officer that was shot at in the same area and it was said that these were

the people trying to protect their patch. According to O'NEAL, the boys were supposedly going to the patch that night and had said they were going to take a gun and a flashlight for protection and that is when the guys killed them. O'NEAL stated that there were a lot of people coming around and talking and this was basically what everyone had said. O'NEAL stated he could not remember who said these things and there were no names mentioned of who the blacks were in connection with this incident.

O'NEAL stated that he went to Alexander and checked with his connections and everyone kept saying, ""GARY didn't do it." O'NEAL stated that he thought the guy's name is GARY PETERS.

According to O'NEAL when he was in the Care Unit he met a MATTHEW LEE who said he had a lot of Chinese connections and DON HENRY had the same Chinese connections and was probably killed by the Chinese Mafia.

O'NEAL stated that a girl named JENNIFER ALTON who lives in Ranchette said that the marijuana field was two to three miles down a road that has a locked gate that is near the traces. O'NEAL stated he has heard that people are still around the patch but he could take us to where the gate was. O'NEAL stated he knew about this plot before the boys were killed. According to O'NEAL, someone had told him about the plot. O'NEAL stated that JEFF MADDEN had ripped a marijuana patch of near shackleford. Road in Little Rock and got about five (5) pounds of "pot" and was selling this and making money. O'NEAL stated that this looked pretty good, so he started looking for some marijuana plots and when he was told about this one he started thinking about it but he was also told that the plot was guarded so he didn't go to this marijuana field.



Approximately 11:00 a.m. on July 15, 1988, this investigator interviewed RAYMOND GRIEBEL in reference to information concerning this investigation. The following will be the information related to this investigator by Mr. GRIEBEL.

According to Mr. GRIEBEL he met DON HENRY through DON's sister GAYLA, approximately ten (10) years ago. GRIEBEL stated that GAYLA married his best friend CHRIS BALLARD and that is when he became associated with GAYLA and DON HENRY.

GRIEBEL stated that approximately four to five days before DON HENRY died that he saw DON outside DARREN O'NEAL's house. GRIEBEL stated that he was going to DARREN's and DON was leaving. GRIEBEL stated that DON asked him if he needed any cocaine and he told DON "no", and DON stated something to the effect, "Let me know, I have plenty." GRIEBEL stated that he did not see any cocaine and thought that DON was by himself. GRIEBEL stated that he went into O'NEAL's and nothing was said about DON or the cocaine. According to GRIEBEL he really did not know how DARREN O'NEAL knew DON HENRY. GRIEBEL stated he did not know of DARREN O'NEAL dealing drugs. GRIEBEL stated that this is the first time that he knew that DON was involved in cocaine. GRIEBEL stated he did know that DON HENRY would smoke marijuana.

GRIEBEL advised that the next time that he saw DON was the Saturday night before his death and DON was with KEVIN IVES. GRIEBEL stated that he was with his girlfriend KRISTY KING and they were going to a movie in Little Rock and were on University Avenue in Little Rock when DON drove up beside them in his car and KEVIN was in the passenger's seat. "We rolled down the windows and asked them where they were going and they just said they were riding around. They asked me what I was doing and I told them I was going to a movie and DON said that he might see me later that night." GRIEBEL stated that usually he saw DON HENRY riding on Geyer Springs and this is what he thought DON meant when he said he might see them later. GRIEBEL stated he

did not see them with any alcohol or drugs. According to GRIEBEL that was the last time that he saw DON HENRY and KEVIN IVES and this was around 7:15 p.m. GRIEBEL stated that he really did not know KEVIN at all and usually just saw him with DON.

GRIEBEL stated that DARREN O'NEAL got put into Rivendale about a month after the boys' death. GRIEBEL stated that while O'NEALwas there he met a guy named MATTHEW LEE and LEE had told that the boys had either taken some cocaine from someone or took some but of a stash and didn't pay the guy some money. GRIEBEL stated that the boys were supposed to meet the guy that they had owed the money to at Shobe Road intersection and KEVIN and DON came to the intersection and when DON and KEVIN got out there was a man who fired some shots at them to scare them and one of the shots accidentally hit one of the boys so they had to kill both of the boys. GRIEBEL stated that the information was that there were supposed to have been four other guys in the bushes to help the first two. GRIEBEL stated something was said about these people being real big Mafia type people. GRIEBEL stated no names were mentioned but LEE was supposed to know the whole story. GRIEBEL stated that he called Mrs. HENRY as soon as he heard about this and told her about this information.

Mr. GRIFFIN advised that he Thew KEVIN EVES and DON HENRY through DON's sister GAYLA. GRIFFIN stated that GAYLA HENRY lived with his wife and himself for about two to three months and DON and KEVIN would come by their house to visit GAYLA and this is how he got to know them.

GRIFFIN stated that the last time he saw DON and KEVIN was approximately 3:30 to 4:00 p.m. on the Saturday before they got killed. GRIFFIN stated that they drove up to his house looking for GAYLA, but GAYLA wasn't there. GRIFFIN stated they stayed for approximately ten (10) minutes and asked where GAYLA was and he said that he didn't know. GRIFFIN stated he does not remember saying much more to the boys at that time. GRIFFIN stated he does not think his wife was present during this time and thought that she may have gone to the store.

GRIFFIN stated that DON HENRY left a joint for GAYLA and so he knew they had some marijuana. GRIFFIN stated that they didn't say where they got the marijuanaaand didn't say anything to him about trying to buy marijuana from him. GRIFFIN stated that he thought they may have asked to buy some from him before, but he stated that he had never sold DON or KEVIN any kind of drugs. GRIFFIN stated he did not know the boys that well and did not know who they were buying drugs from. GRIFFIN stated he did not remember GAYLA ever saying anything about the boys buying drugs.

.According to GRIFFIN when he talked to Mr. HARMON, he told HARMON that he knew what they had and by this he stated that he meant the marijuana and

During this interview, Ms. ROBERTSON stated that she had given the following information to a Little Rock Bolice Department officer and a Benton Police Department officer prior to this interview; however, she could not recall the names of the officers.

Ms. ROBERTSON stated that sometime in late summer or early fall, 1987, she was using the pay phone outside the Circle "K" Store on University Avenue in Little Rock and next to her was a black male whom she recognized as an old school mate from McClellan High School. While the unidentified black male was using the phone another former McClellan student, LOYD MCELROY, came out of the store and started talking to the black male. The essence of the conversation was as follows: "They" knew that he had "taken care" of someone and he had to "take care" of them. DON HENRY or CALVIN IVES names' were not mentioned during the conversation and Ms. ROBERTSON could not remember anymore of the conversation. After this conversation took place the two individuals got into a car and left without either one of them having seen Ms. ROBERTSON.

Ms. ROBERTSON stated that she knew LOYD MCELROY because he sat next to her in Algebra at McClellan High School. She graduated from McClellan in 1986. She stated the black male was also a McClellan student during this time, but she could not recall his name. This interview was concluded at 5:00 p.m.

This interview was conducted with Mr. RANDALL at J. R.'s Auto Sales in Little Rock, Arkansas, commencing at 3:54 p.m. on July 20, 1988, by Investigator DAVE DILLINGER. No one else was present during this interview.

During this interview, Mr. RANDALL stated that he knew KEVIN IVES for about six months to a year prior to his death. He stated that he had worked on IVES' car, installing a radio. According to RANDALL, IVES was known to smoke "a lot" of dope and It was Mr. RANDALL's opinion that IVES and HENRY did not lay down on the rail Foad arack.

Concerning lead number 85, Mr. RANDALL stated that he also knew JAMES CALLAWAY. However, he denied making the statement that CALLAWAY had sent the boys to the railroad tracks in Alexander on the night of their deaths. He also stated that he did not know where this information could have come from.

(NOTE: When this investigator went to J. R.'s Auto Sales on Baseline Road in an attempt to locate Mr. RANDALL, he was initially informed by someone at the auto sales, apparently Mr. RANDALL's employer, that he was not present. After a brief conversation with the employer, this investigator was instructed to wait in an office at the auto sales and Mr. RANDALL appeared two or three minutes later. Mr. RANDALL informed this investigator that he was in the process of calling his lawyer when he found out that a State Police investigator was looking for him and seemed relieved that the purpose of the visit was an interview rather than an arrest. It was also determined by this investigator, while attempting to locate Mr. RANDALL on Polk Road in Alexander that his neighbors held him in universally low regard and did not seem surprise that a State Police investigator was attempting to locate Mr. RANDALL.)

#### INVESTIGATOR'S NOTES





#### INTERVIEW OF WITNESS

At approximately 8:50 a.m. on July 21, 1988, this investigator interviewed SHANNON HINES in reference to information she might have concerning this investigation. The following will be the information related to this investigator by Ms. HINES.

HINES stated that she didn't know KEVIN IVES very well, but that she had met him while KEVIN was working at the Safeway on Geyer Springs in Little Rock, Arkansas. HINES stated that she had known KEVIN for a little less than a year. According to HENES, the only time she ever saw KEVIN was at the Safeway Store on Geyer Springs. HINES stated that she did not know DON HENRY.

HINES stated that one day KEVIN asked her if she wanted to go steal some marijuana and she asked him what he was talking about and he said it was down near the police station off Mann Road in Little Rock. HINES stated that KEVIN did not say how he knew the marijuana was there and this was the first time that he had mentioned anything to her about the marijuana patch. HINES stated that he did not say anything about anyone guarding the plants and that he told her this about three months before he was killed. HINES stated that she told him that she did not want to go with him to steal marijuana and in fact did not go with KEVIN IVES.

HINES stated that this was the first time that KEVIN had evercome out and directly said something to her about drugs. HINES went on to state that she knew that KEVIN got high but she never saw him with anything. According to Ms. HINES, KEVIN never said anything to her about being in any kind of trouble.
